

## Takaful *myClick* Motor Lucky Draw Campaign (hereinafter referred to as “Lucky Draw”)

### Terms & Conditions (T&C)

1. This Lucky Draw is organised by Syarikat Takaful Malaysia Am Berhad [Company No. 201701032316 (1246486-D)] (hereinafter referred to as “Takaful Malaysia”).
