

Takaful *myClick* Motor Lucky Draw Campaign

Terms & Conditions (T&C)

1. This Lucky Draw is organised by Syarikat Takaful Malaysia Keluarga Berhad including its subsidiary Syarikat Takaful Malaysia Am Berhad (“Takaful Malaysia”) and its partner namely 8excite Sdn. Bhd. (“8excite”). Takaful Malaysia and 8excite are collectively referred to as (“the Organiser”).
2. This Lucky Draw shall run for four (4) months from 15th April 2021 until 14th August 2021 (both dates inclusive, “Campaign Period”).
3. This Lucky Draw is open to Takaful Malaysia customers with in force Takaful *myClick* Motor certificates (“the Applicant”) during the Campaign Period subject to the following eligibility requirements:
