<p><b>1. What is this product about?</b></p>	
<p>The Product provides comprehensive coverage for contractors to meet their obligations under contract conditions for projects works involving erection of machinery, plant, steel structures of any kind awarded to them for projects associated with erection, installation, testing and commissioning at a project site. The product can also provide coverage for the duration of erection work including testing/commissioning. In addition to the material damage, the product also provides indemnity in respect of third party liability which the Participant shall become legally liable arising out in connection with the execution of a project.</p>	
<p><b>2. What are the Shariah concepts applicable?</b></p>	
<p>This product applies the following Shariah concepts:</p> <ol style="list-style-type: none"> <li>1. <b>Tabarru'</b> means donation for charitable purposes. Under this product, the participant donates a portion of the contribution to the General Takaful Fund (GTF) to help other participants.</li> <li>2. <b>Wakalah</b> refers to a contract where a party, as principal authorizes another party as his agent to perform a particular task on matters that may be delegated, with or without the imposition of a fee. Under this product, the participant authorizes the company to manage the GTF and in return, the company will receive a wakalah fee.</li> <li>3. <b>Ju'alah</b> refers to a contract where a party offers a specified reward to another party who achieved a determined result. Under this product, the participant allows the company to receive a portion of distributable surplus arising from the GTF as performance incentive for the Company's achievement in managing the GTF which results in the surplus.</li> <li>4. <b>Qard</b> refers to a contract of lending money by a lender to a borrower where the latter is bound to repay an equivalent replacement amount to the lender. Under this product, the company will lend an amount of money to the GTF without interest if the GTF is in deficit.</li> </ol>	
<p><b>3. What are the covers / benefits provided?</b></p>	
<p>This Product provides cover in respect of:</p> <p><u>Section I – Material Damage</u> It covers almost any sudden and unforeseen physical loss or damage occurring to the contract works/property/items covered during the period of takaful, other than those specifically excluded under the certificate.</p> <p><u>Section II – Third Party Liability</u> This section is in respect of third party liability for which you may become legally liable to pay as damages <u>consequent</u> upon:</p> <ul style="list-style-type: none"> <li>• Accidental bodily injury to or illness of third party.</li> <li>• Accidental loss or damage to property belonging to a third party.</li> </ul> <p>Duration of cover <u>corresponds</u> to the contract period, including a maintenance period as stipulated in the Letter of Award. You need to participate in a new Certificate to cover each project undertaken.</p>	

**4. How much contribution do I have to pay?**

The total annual contribution that you have to pay may vary depending on the risk exposure, our underwriting requirements and sum covered of the property.

Subject to a minimum contribution of RM250.00.

**5. What are the fees and charges that I have to pay?**

**6. What are some of the key terms and conditions that I should be aware of?**

Some of the key terms and conditions that you should be aware of are:

- **Duty of disclosure**

- **Non-Consumer Takaful Contract**

- Pursuant to Paragraph 4(1) of Schedule 9 of the Islamic Financial Services Act 2013, if you are applying for this takaful for a purpose related to your trade, business or profession, you have a duty to disclose any matter that you know to be relevant to our decision in accepting the risks and determining the rates and terms to be applied and any matter a reasonable person in the circumstances could be expected to know to be relevant, otherwise it may result in avoidance of your contract of takaful, refusal or reduction of your claim(s), change of terms or termination of your contract of takaful. The above duty of disclosure shall continue until the time your contract of takaful is entered into, varied or renewed with us. You also have a duty to tell us immediately if at any time after your contract of takaful has been entered into, varied or renewed with us any of the information given in the Proposal Form (or when you applied for this takaful) is inaccurate or has changed.

- **Change in Risk** - you must inform the company or your agent in writing of any material changes during the certificate period so that the necessary amendments are endorsed into your certificate.
- **Duty of Participant** - you shall take all reasonable precautions for the safety of the property covered.
- You must ensure that your property are covered at the appropriate amount, either on:
  - a) **Market value basis** – we will pay the full cost of repairing the damaged property less the amount for wear, tear and depreciation.
  - b) **Replacement value basis** – we will reinstate, repair or replace the loss or damaged property without any deductions being made for wear, tear or depreciation provided that the sum covered is adequate to cover the total cost of replacing.
- **Under coverage** – you must ensure that the sum covered is adequate, otherwise, average condition will apply for under coverage at the time of loss. You shall be considered as covering for yourself the difference and shall bear the rateable proportion of the loss accordingly.
- **Excess** - is the first amount of loss that you have to bear in the event of a claim.

**7. What are the major exclusions under this product?**

This Product does not cover certain losses, such as:

- i) War, invasion, act of foreign enemy, hostilities, riot, strike etc.
- ii) Nuclear reaction, radiation, radioactive and contamination.
- iii) Wilful act or wilful negligence of any official of the Participant

<ul style="list-style-type: none"> <li>iv) Partial or total cessation of work due to lack of use.</li> <li>v) Consequential loss.</li> <li>vi) Bodily injury to or illness of employees or workmen of the contractor(s) or the principal(s).</li> <li>vii) Any accident caused by vehicles licensed for general road use or by waterborne vessel or aircraft.</li> <li>viii) Any other events prohibited by Shariah principles.</li> </ul> <p>Note: This list is non-exhaustive. Please refer to the Certificate for the full list of exclusions under this product.</p>
<p><b>8. Can I cancel my certificate?</b></p> <p>You may cancel your certificate by giving a written notice to us. Upon cancellation, you are entitled to a partial refund of the contribution provided you have not made any claim.</p>
