# **FAMILY CLAIMS GUIDE**

Please refer to the following step-by-step guide to submit your family claims.

### STEP 1: COMPILE THE FOLLOWING DOCUMENTS

Documents required for Death Claims:

- 1. Original Death Claim Form (Please click here to download the claim form)
- 2. Death Certificate duly certified
- 3. Deceased's NRIC duly certified
- 4. Claimant's NRIC duly certified
- 5. Marriage Certificate (for spouse) or Birth Certificate (for children or parents) duly certified
- 6. Beneficiary/ Claimant/ Nominee/ Bank Account details or Direct Credit Form
- 7. Letter of Administration or Grant of Probate
- 8. Burial Permit/ Certificate duly certified, if applicable

Additional documents required for accidental death as follows:-

- 1. Police Report duly certified
- 2. Port mortem report/ autopsy report duly certified, if applicable
- 3. Toxicology report duly certified, if applicable
- 4. Newspaper cutting, if applicable

Additional documents for overseas death as follows:-

- 1. Letter of confirmation of death by National Registration Department (JPN)
- 2. Embarkment certificate for foreign death duly certified

Documents required for Total & Permanent Claims:

- 1. Duly completed TPD Claim Form (Please click here to download the claim form)
- 2. TPD Claim To be completed by the attending physician (after 6 months from the disability date\*)
- 3. Claimant's NRIC duly certified
- 4. Employment Termination Letter duly certified (For gainfully-employed person)
- 5. SOCSO Offer Letter/ SOCSO "Keputusan Jemaah Doktor Mengenai Keilatan" duly certified, if applicable
- 6. Beneficiary/ Claimant/ Nominee/ Bank Account details or Direct Credit Form
- 7. Police Report duly certified (accidental cause)
- 8. Newspaper Cutting (accidental cause), if applicable

Documents required for Critical Illness Claims:

- 1. Duly completed Critical Illness Claim Form (Please click here to download the claim form)
- 2. Claimant's NRIC duly certified
- 3. Medical report according to the specific type of the critical illness claim
- 4. Copy of all relevant test results, hospital reports, CR/ MRI scan, x-ray, biopsy/ histopathology report.

\*Not applicable for clear cut TPD claims such as amputation, end stage kidney failure, etc.
