The tenure of Sukuk Wakalah Programme is perpetual whereas the T2 Sukuk Wakalah to be issued under Sukuk Wakalah Programme shall have a tenure of not less than five (5) years from the issue date.

STMKB has been accorded a Takaful Financial Strength rating of AA2 by RAM Rating Services Berhad ("RAM"), whereas Sukuk Wakalah Programme has been accorded a credit rating of AA3 by RAM.

The proceeds of T2 Sukuk Wakalah shall be made available for working capital and corporate purposes of the Company and refinancing of the T2 Sukuk Wakalah and/or Shariah compliant capital instruments. For avoidance of doubt, utilisation of proceeds shall at all times be for Shariah-compliant purposes.
